### ARTICLES OF INCORPORATION **OF**

# SCHOOL STATES FLORIDA MEDICAL CANNABIS ASSOCIATION, INC.

(A Corporation Not-For-Profit)

The undersigned, in accordance with the provisions of Chapter 617, Florida Statutes, hereby submits the following Articles of Incorporation of Florida Medical Cannabis Association, Inc.

#### Article 1: Name

The name of the corporation is: Florida Medical Cannabis Association, Inc.

#### Article 2: Purposes

The corporation is organized exclusively as a trade association within the meaning of § 501(c)(6) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. To the extent consistent therewith, those purposes may include the following:

- To promote the development in Florida of a medical cannabis industry; A.
- To provide an awareness of the need for the education and treatment of those В. suffering from medical conditions for which medicinal cannabis provides relief;
- C. To enhance the system for the delivery of services to those for whom medical cannabis products have been prescribed in accordance with law;
- D. To engage in such additional activities permitted by law as may be necessary in furtherance of the exempt purposes of the corporation.

Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under § 501(c)(6) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. No part of the net earnings of the corporation shall inure to the benefit of any private shareholder or individual.

Article 3: Members

The corporation may have two classes of members: (a) voting, and (b) non-voting as the Bylaws of the corporation. provided by the Bylaws of the corporation.

The duration of the corporation shall be perpetual.

#### Article 5: Board of Directors

The affairs of the corporation shall be managed by a Board of Directors which shall consist of at least three (3) members and not more than prescribed by the bylaws of the corporation. The method of election of directors shall be as stated in the bylaws of the corporation. The initial directors of the corporation are the following to serve until their successors are duly nominated and confirmed:

Article 6: Distribution of Assets Upon Dissolution

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of § 501(c)(6) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of applicable jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
