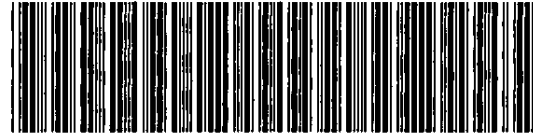

Effective March 3, 2014

Third: The Club is organized to educate, promote and share its knowledge of flower gardens --- their design and culture and the preservation of Florida wildflowers and native plants/trees through monthly meetings, educational programs, civic plantings and other activities and to encourage advanced studies through the issuance of scholarships to deserving high school senior students.



Sixth: The Registered Agent is Sonia Ricchini – 10430 Goshawk Dr., Riverview, FL 33578.


Seventh: The Incorporator is Charles H. Fisher, 3803 Turkey Oak Dr., Valrico, FL 33596.
