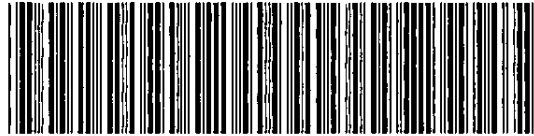

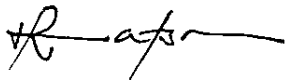

**ARTICLES OF INCORPORATION OF
CHRIST GRACE INCORPORATED**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

1. The name of the Corporation is **CHRIST GRACE INCORPORATED**.
2. The principal street address of the principal office and place of business is:

10347 Sequoya Drive
Jacksonville FL. 32257.
3. The specific purpose for which the corporation is organized is to minister the New Covenant of Grace to mankind, so that God will manifest His Glory in all who believe. By the Word Of God, Corporate Worship and Prayer we will demonstrate the Kingdom, Power and Glory of God through Signs, Wonders and Miracles. Evangelizing the unsaved and Equipping the saved, through service and outreach to others. To execute the responsibilities of ministry according to lawful, ethical and spiritual standards: uphold, safeguard and promote the organization's philosophy, mission, vision, and values through ethics and integrity. Ensure that standards are incorporated into policies and procedures. In order to achieve corporate church and social responsibility within the church and neighboring communities through service excellence, equality, education, mentoring, development and other various forms of religious ministry.
4. The manner in which the directors are elected or appointed is that the directors are appointed by the incorporator and thereafter the directors are elected pursuant to the Bylaws of the corporation.

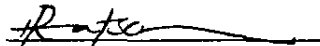
6. This organization is a nonprofit religious organization and is not organized for the private gain of any person. It is organized exclusively for religious purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
7. No substantial part of the activities of this organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, except as otherwise provided by Section 501(h) of the Internal Revenue Code, and the organization shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
8. The property of this organization is irrevocably dedicated to religious purposes. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its directors, officers, members, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
9. Notwithstanding any other provision of these articles of incorporation, this organization shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this organization, and the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
10. Upon the dissolution of the organization, assets remaining after payment, or provision for payment, of all debts and liabilities of this organization, shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a nonprofit fund, foundation or organization which is organized and

operated for religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

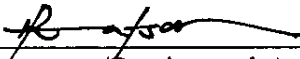

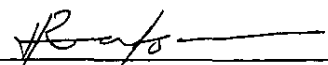
