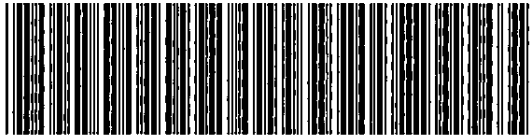

Article  VIII .
