The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

Article I. Name

The name of the corporation is ORLANDO CURLING CLUB CORP.

Article II. Principal Place of Business and Mailing Address

The principal place of business and mailing address of the club is initially:

Article III. Purpose

The purpose of this club is to teach, develop, promote and encourage the sport of Curling; to develop youth and adult programs that lead to local, national and international competition; to coordinate and develop interscholastic competition; and to teach the sport to youth organizations as well as to interested adults by creating public awareness and appreciation for the sport.

Article IV. Management

All power to control and manage the club is vested in the Board of Directors except as may be otherwise limited in the bylaws.

Article V. Election of Directors

Directors are elected or appointed in the manner and for the terms provided in the bylaws.

Article VI. Directors

Article VII. Tax-Exempt Status

Funding will be derived through contributions and donations from the public and private sectors for carrying out the aforesaid purposes, and membership dues.

The corporation is non-profit and shall not have, issue, or distribute shares of stock.

No part of the net earnings of the club shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the club shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the club shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the club shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the club shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII. Dissolution

Upon the dissolution of the club and after paying or making provisions for the payment of all the liabilities of the club, remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the club is then located, exclusively for such

purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

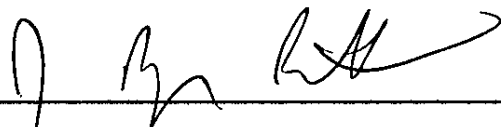

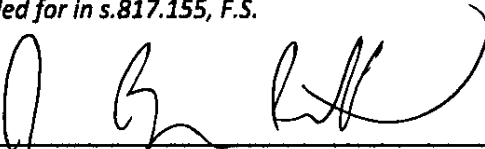
