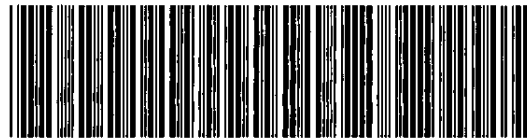

NONPROFIT CORPORATION ARTICLES OF INCORPORATION OF YOUNG @ HEART KIDZ FOUNDATION INC.

Pursuant to Chapter 617.0202 of the laws of Florida State, the undersigned majority of whom are citizens of the United States, do hereby submit these Articles of Incorporation for the purpose of forming a nonprofit corporation.

ARTICLE 1

Name

The name of the corporation shall be Young @ Heart Kidz Foundation, Inc.

ARTICLE 2

Principal Office

The place in the State of Florida where the principal office of the Corporation is to be located is 7601 E. Treasure Drive, Unit CU-1, North Bay Village, zip 33141 in the City of Miami, zip 33141, in Miami Dade County.

ARTICLE 3

Purpose

The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code and herein stated as follows:

To educate parents on Applied Behavior Analysis, create an enrichment center for kids with behavioral problems and disability programs by implementing activities supported by scientifically based research assisting children with educational material and toys, whose parents are below poverty level.




