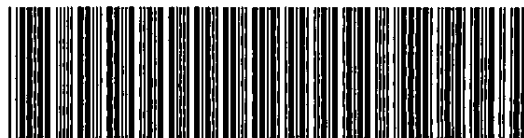

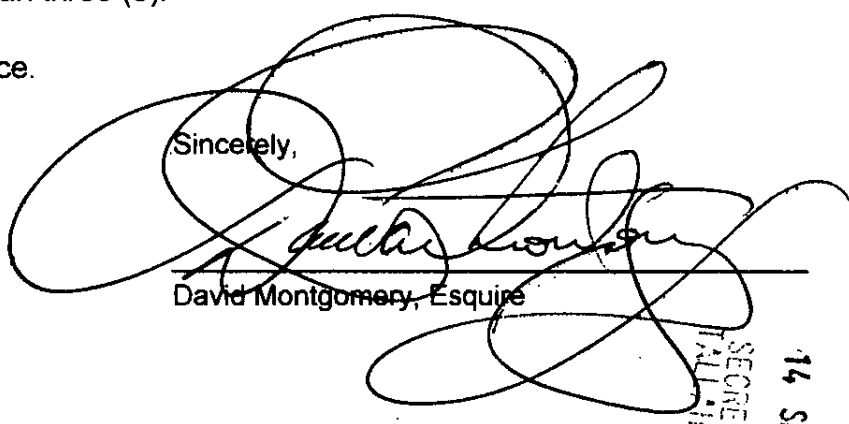

We, the undersigned, all of whom are citizens of the United States and residents of the State of Florida, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

First: The name of the Corporation shall be **Drive for Diabetes Awareness, Inc.** and the term of this corporation shall be perpetual with its **effective date** on the **date of filing** hereof with the office of the Florida Secretary of State.

Second: The place in this state where the principal office of the Corporation is to be located in either Sarasota or Manatee Counties, Florida, with the initial principal office located at 2318 Spring Oaks Circle, Sarasota Florida 34234 and the mailing address for this Corporation shall be 2318 Spring Oaks Circle, Sarasota Florida 34234.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Generally and not be way of limitation in any manner whatsoever,

"It shall be the mission of this corporation to create public awareness of the need for diabetes screening, particularly of young children, and to distribute information by pamphlets and similar communications at sporting events and otherwise to inform the public about the symptoms of diabetes and dangers of unknown or untreated diabetes for the support for those dealing with a diagnosis of, or research related to, juvenile diabetes such as by promoting the slogan of: "Check Don't Guess."

Fourth: The names and addresses of the persons who are the initial directors and officers of the corporation, whose successors shall be selected from time to time by action of the majority of the then officers and directors but the number of whom shall never be less than three (3), are as follows:

Fifth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for

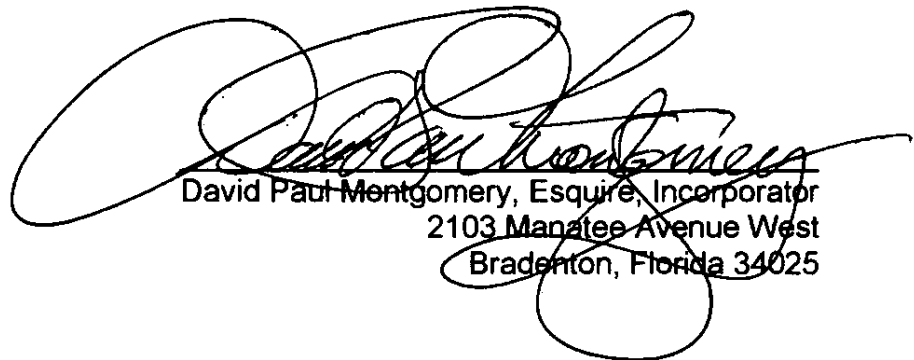
public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

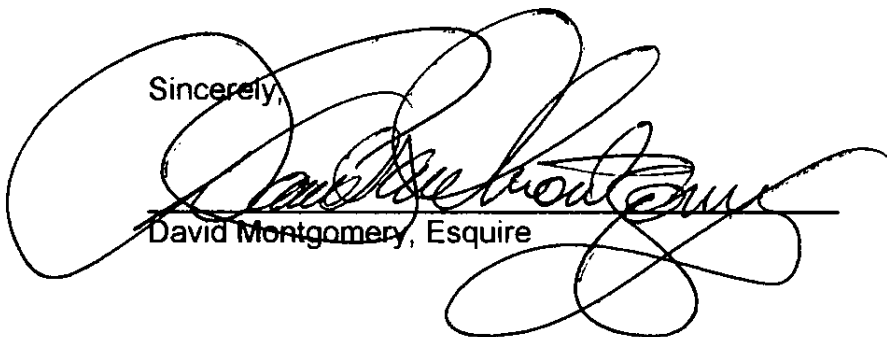
