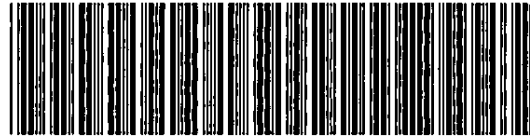

Articles of Incorporation of Affirmation Church, Inc.

SEP 18 PM 12:25

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I: The name of the Corporation shall be Affirmation Church, Inc.

Article II: The place in this state where the principal office of the Corporation is to be located is the City of Fleming Island, Clay County. The principal address of the Corporation is 1840A Green Springs Circle, Fleming Island, FL 32003. The mailing address of the Corporation is P.O. Box 2742, Orange Park, FL 32067.

Article III: Said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV: The names and addresses of the persons who are the initial Directors of the Corporation are as follows:

La Ronda D. Barnes, Chairperson, P.O. Box 2742, Orange Park, FL 32067

Mary Cook, Director, 1840A Green Springs Circle, Fleming Island, FL 32003

Jaye Stephens, Director, 219 Campbell Avenue, Apt. C, Orange Park, FL 32073

Article V: The initial Directors have been appointed by the Incorporator. Appointment of new directors will be as set forth in the Corporation's Bylaws.

Article VI: Registered Agent: The name and Florida street address of the registered agent is Mary Cook, 1840A Green Springs Circle, Fleming Island, FL 32003.

Article VII: The name and address of the Incorporator is La Ronda Barnes, P.O. Box 2742, Orange Park, FL 32067.

Article VIII: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in

any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IX: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article X: The effective date of these Articles of Incorporation is September 15, 2014.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
