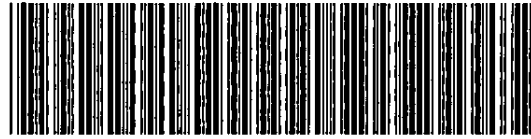

Articles of Incorporation for NET-PLAY TENNIS, INC.

ARTICLE I

1.01 Name

The name of the corporation shall be Net-Play Tennis, Inc.

ARTICLE II

2.01 Principal Office

The address of the principal office of Net-Play Tennis, Inc. in the State of Florida is 2780 E. Fowler Ave, Suite 233, Tampa, FL 33612.

2.02 Mailing Address

The mailing address of the principal office of Net-Play Tennis, Inc. is 2520 Vestal Pkwy E. PMB# 179, Vestal, NY 13850.

ARTICLE III

3.01 Purpose

Net-Play Tennis, Inc. is a non-profit corporation and shall be operated exclusively for charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

The specific purpose of Net-Play Tennis, Inc. is to increase the exposure of youths in underprivileged communities to tennis by giving them an opportunity to learn its fundamentals from tennis professionals certified in Junior Development instruction.

Net-Play Tennis, Inc. provides education by hosting free weekend junior tennis clinics and workshops in pre-selected public parks as well as utilizing social media channels and Net-Play Tennis, Inc.'s website to provide facts, statistics & other tennis related data, and information regarding current & upcoming Net-Play Tennis, Inc. events.

At times, per the discretion of the Board of Directors, Net-Play Tennis, Inc. may provide internships or volunteer opportunities for high school students within local public school districts which shall provide opportunities for involvement in said activities in order to have a greater impact in local communities.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for educational and charitable purposes.

ARTICLE IV

4.01 Non-profit Nature

Net-Play Tennis, Inc. is organized exclusively for educational and charitable purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of Net-Play Tennis, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that Net-Play Tennis, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, Net-Play Tennis, Inc. shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Net-Play Tennis, Inc. is not organized and shall not be operated for the private gain of any person. The property of Net-Play Tennis, Inc. is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of Net-Play Tennis, Inc. shall inure to the benefit of, or be distributed to any individual. Net-Play Tennis, Inc. may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

4.02 Personal Liability

No officer or director of Net-Play Tennis, Inc. shall be personally liable for the debts or obligations of Net-Play Tennis, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of Net-Play Tennis, Inc.

4.03 Dissolution

Upon termination or dissolution of Net-Play Tennis, Inc., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to Net-Play Tennis, Inc.

The organization to receive the assets of Net-Play Tennis, Inc. hereunder shall be selected by the discretion of a majority of the managing body of Net-Play Tennis, Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Net-Play Tennis, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to Net-Play Tennis, Inc., then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

4.03 Prohibited Distributions

No part of the net earnings, or properties of Net-Play Tennis, Inc., on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that Net-Play Tennis, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

4.04 Restricted Activities

No substantial part of Net-Play Tennis, Inc.'s activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and Net-Play Tennis, Inc. shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.05 Prohibited Activities

Notwithstanding any other provision of these Articles, Net-Play Tennis, Inc. shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to

which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V

5.01 Governance

Net-Play Tennis, Inc. shall be governed by its Board of Directors. Board elections and appointments will be as provided for by Net-Play Tennis, Inc.'s Bylaws

5.02 Board of Directors

The initial Board of Directors of Net-Play Tennis, Inc. shall be President, Anthony Q. Bronner; Secretary, Elizabeth Bray; and Treasurer, Senanu Asamoah.

ARTICLE VI

6.01 Membership

Net-Play Tennis, Inc. shall have no members. The management of the affairs of Net-Play Tennis, Inc. shall be vested in a Board of Directors, as defined in Net-Play Tennis, Inc.'s Bylaws.

ARTICLE VII

7.01 Amendments

Any amendment to the Articles of Incorporation may be adopted by approval of two-thirds (2/3) of the Board of Directors.

ARTICLE VIII

8.01 Effective Date and Duration

The effective date of incorporation for Net-Play Tennis, Inc. will be January 1, 2015. The period of duration is perpetual.
