# ARTICLES OF INCORPORATION OF SHASTA'S KIDS, Inc.

ARTICLE 1: The name of this corporation is: SHASTA'S KIDS, INC.

**ARTICLE II:** The principal office of the corporation shall be

**ARTICLE III:** The purpose for which the corporation is organized is charitable, literary and educational.

The Corporation shall provide the following purposes and or services:

- (a) To foster Continuing Education and Academic Achievement to Low Performing Students by providing Afterschool Tutorial Assistance, Computer Literacy, Literacy, Leadership & Educational Workshops, Mentoring, Internship/Community Service Opportunities, Individual/Group Counseling, Scholarship Awards and a fun Educational Early Learning Child Care Program.
- (b) To create a forum that will develop the whole person spirit, mind and body through Life Building Skills, Career Development/Job Readiness and Economic Development that will empower individuals to become productive citizens and a Multicultural arts, Summer Program.

- (f) To provide services to all qualifying clients, in accordance with all applicable state and federal anti-discrimination statutes and to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors or officers, except as permitted under Article 5 of the Not-for-Profit Corporation Law.

#### ARTICLE VIII:

Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the purposes as specified in 501(c)(3) of the Internal Revenue Code of 1954 (the "IRC"), and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under IRC 501(c)(3) or corresponding provisions of any subsequent Federal tax laws.

No part of the net earnings of this corporation shall inure to the benefit of any member, trustee, director, officer, of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporation assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRC 501(h)), and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC 501(c)(3), or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.

In any taxable year in which this corporation is a private foundation as described in IRC 509(a), the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under IRC 4942, and the corporation shall not (a) engage in any act of self-dealing as defined in IRC 4941(d), retain any excess business holdings as defined in IRC 4943(c), (b) make any investments in such manner as to subject the corporation to tax under IRC 4944, or (c) make any taxable expenditures as defined in IRC 4945(d) or corresponding provisions of any subsequent Federal tax laws.
