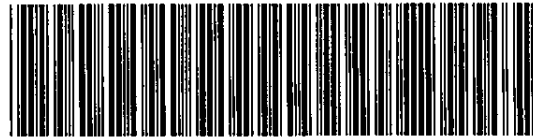

The name of this corporation shall be Prayer of Faith International Temple Apostolic, Inc.

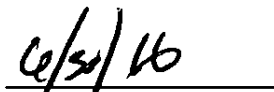
Amendments Adopted
