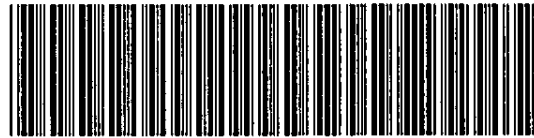

AMENDMENT TO ARTICLE III – PURPOSE


