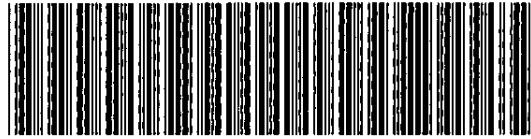

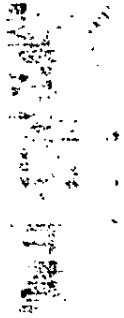

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida do hereby form the Corporation:

**ARTICLES OF INCORPORATION**  
In compliance with Chapter 617, F.S., (Not for Profit)

**Article I NAME:** The name of the Corporation shall be Sephardic Hemisphere Minyan Corp.

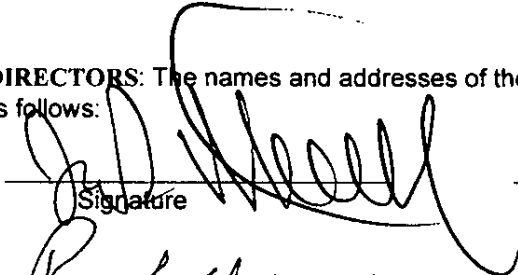
**Article II PRINCIPAL OFFICE:** The place in this state where the principal office of the Corporation to be located is 1950 S. Ocean Drive, Apt #11Q, in the City of Hallandale Beach, FL, 33009 in Broward County. The mailing address is the same. Mail to be addressed care of Mr. Jack E. Mamiye, President.

**Article III PURPOSE:** The principal purpose is a religious organization (Synagogue) formed to service Sabbath and Festival prayers for elderly congregants that would not otherwise be able to attend such services (mainly due to physical constraints of travel.) Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


**Article IV MANNER OF ELECTION:** (The manner in which the directors are elected and appointed) All the Members of the religious organization are to have EQUAL VOTE in the policy and concern of same. Elections shall be made each year by the Members to elect the officers and directors of Corporation by Majority vote. The term of service shall be 1 year unless otherwise agreed upon by the super majority of the Members.

**Article VI ACTIVITIES:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.



**Article VII DISSOLUTION:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
