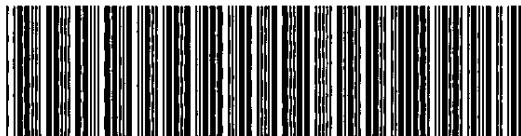


To: Thomas Chang,


