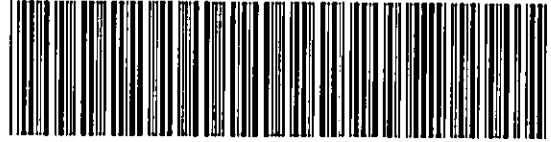

The name of the Corporation is:

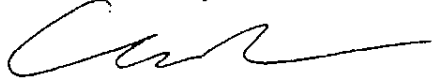
ROSSER ~~RESERVE~~ LAKE DOWN RESERVE HOMEOWNERS' ASSOCIATION, INC."
