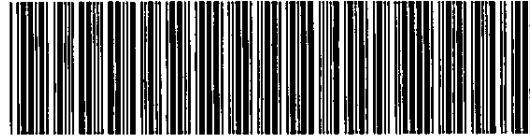

No part of the earnings of this organization shall ever inure to the benefit of or distributable to its members, trustees, officers or other private persons (except that reasonable compensation may be paid for services rendered to or for the organization affecting one or more of its purposes), and no director or officer of the organization, or any private individual shall be entitled to share in distribution of any assets upon dissolution.
3. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate, or intervene in political campaign on behalf of or in opposition of any candidate for public office.
4. Upon winding up and dissolution of the organization, after paying or adequately providing for the debts and obligations of the organization, remaining assets shall be distributed to a nonprofit trust, foundation or organization that is organized and operated exclusively for charitable, educational or religious and/or scientific purpose.

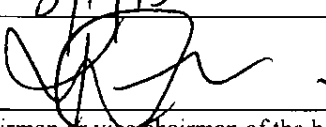
