The Articles are hereby Amended as follows:

Article III :Said Organization is organized exclusively for Charitable, Religious, Educational and Scientific purposes, including, for such purposes, the making of distributions to Organizations that qualify as exempt Organizations described under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of an future Federal Tax code.

Article VIII: Upon the Dissolution, Assests shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding Section of any future tax code or shall be distributed to the Federal Government or to a State or local Goernment for a Public purpose. Any such assets not disposed of by a Court of competent jurisdictionn in the county in which the principal office of the Organization is then located, exclusively for such puposes or to such Organization or Organizations , as said Court shall determine,which are organized and operated exclusively for such purposes.

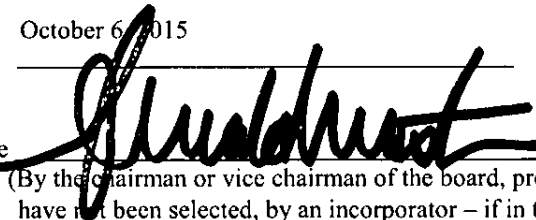
