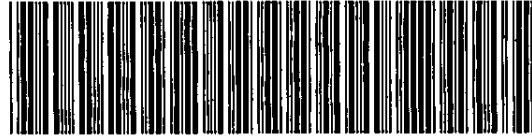


1. The name of the corporation is **THE WOMEN OF ST. JAMES CATHOLIC CHURCH, INC.**

4. The effective date of this Amendment shall be its filing date.

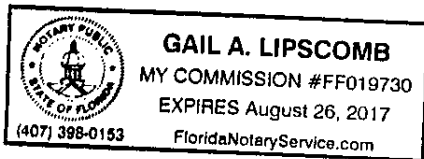
