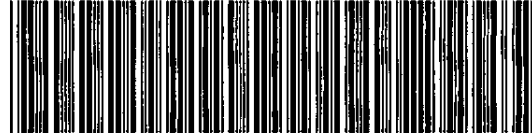

(Amend) Article III - The purpose of purposes for which the corporation is formed are as follows:

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose of the corporation is to function as a non-profit charitable foundation and as such, to receive, hold and administer funds, securities, gifts and bequests and to use, disburse or donate the income or principal thereof for charitable purposes of any subsequent federal law.

(Add) Article VIII - No part of the net earnings of the corporation shall insure to the benefit of any member, trustee, director or officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

(Add) Article IX - In the event of dissolution all of the remaining assets and property of the corporation shall, after necessary expenses, thereof be distributed to another organization exempt under section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or a state or local government for public purposes.
