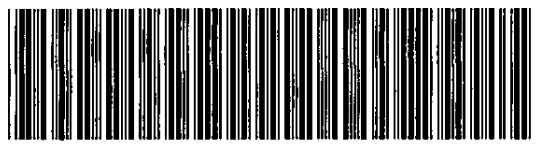

# **ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S., (Not for Profit)

## **ARTICLE 1: Name of Not for Profit Corporation**

The name of the corporation shall be:

## **ARTICLE III: PURPOSE**

The purpose for which the Not-for-Profit Corporation is organized is:

1. The Interstellar Community Foundation, Inc. is a Not-for-Profit established for the purpose of creating a cradle to grave educational system that makes use of a specially designed campus and series of buildings surrounded by sustainable "communities of the future" for the purpose of maximizing and sustaining the highest human potential.

2. The Mission of the Interstellar Community Foundation will focus on three areas: **education, research and support.** In addition to incorporating traditional methodologies for learning, observing and interpreting the world, the Interstellar Community Foundation educational system will incorporate methodologies, processes and modes of learning designed to expand the consciousness and cultivate the whole person. It will include research and exploration into the unseen, subtle energies and realms beyond what the conventional worldview accepts as possible – including extraterrestrial encounters, and shamanic ways of experiencing and interpreting the world. Interstellar Community Foundation, through its integrated systems and structures will seek to create and sustain an energetic field of deep connection, understanding, love, and mutual support. In this way, it is our goal to create a model of sustainable learning and living that, in addition to expanding consciousness, promotes mental, emotional, physical and spiritual well-being, interethnic and intercultural understanding and tolerance, improves interpersonal communication, helps to

eliminate prejudice and discrimination, provides skills for resolving conflicts, and lessens interpersonal and social tensions.

3. Prior to the building of the core educational facility, its campus, and the surrounding sustainable "communities of the future," Interstellar Community Foundation will largely be a Not-for-Profit Educational and Research "think tank." In creating an educational curriculum that integrates both traditional and non-traditional ways of learning, we will identify and engage the brightest minds and most forward thinking educators, and learn from both traditional systems and successful experimental approaches. Our intention will be to incorporate the best in an effort to go beyond what currently exists in curriculum development and teaching methods.

4. In building a campus and set of buildings that draws upon ancient indigenous knowledge of the energies of the directions, and designing it in such a way that augments both the learning process and sustainability of a high-energy environment, we will bring together research into such areas as: new materials of construction, how architectural spaces enhance the learning environment, the effect of crystals on human consciousness, and so on. We will also draw on non-traditional information sources to aid us in this endeavor such as: information gathered from paranormal states of consciousness, and from encounters with extraterrestrial or interdimensional beings.

5. In addition, the Interstellar Community Foundation, in maximizing human potential and establishing "communities of the future," seeks to pave the way for eventual, overt interaction, dialogue and mutual learning between human beings and extra-terrestrial beings and interdimensional, non-human intelligence. To this end, we also intend to focus on the most up-to-date research on extra-terrestrial encounters and other types of "paranormal contact experiences," and related paranormal phenomena through, for instance, the collaboration with other organizations, such as the Foundation for Research into Extraterrestrial Encounters, working in such fields.

6. In establishing the sustainable communities of the future that surround the core educational facility and campus, we will necessarily also have a support mission for those individuals and families that choose to reside in these communities. This is because the community that we foresee will be intimately involved in the education and learning process, and an important part of maintaining a high level of awareness, an expanded consciousness, and a lifestyle based upon openheartedness and mutual support. Individuals who choose to live in these communities must be willing to participate at this level of connectedness.

7. All Interstellar Community Foundation Board of Directors endorse the belief in consciousness as non-local and independent of the brain, the possibility and power of

paranormal or mystical states of consciousness, and the reality of interaction with extraterrestrial and interdimensional beings or intelligences.

#### **ARTICLE VIII: Duration of the Nonprofit Corporation**

The duration of the nonprofit corporation will be "Perpetual."

#### **ARTICLE IX: 501(c)(3) Purpose Language**

1. Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to

organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

2. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of State.

3. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of the corporation is irrevocably dedicated to charitable, educational, and scientific 501(c)(3) exempt purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

4. No substantial part of the Not-for-Profit corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

5. Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment of registered agent and agree to act in this capacity.





