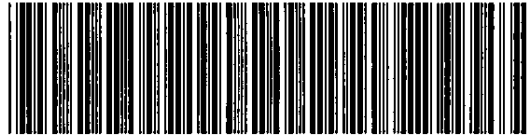

ARTICLE IX DISSOLUTION
