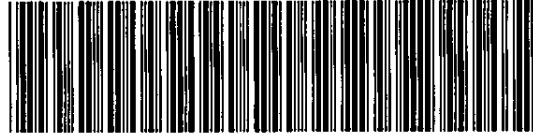

ARTICLES OF INCORPORATION  
In compliance with Chapter 617, F.S., (Not for Profit)

**Article One. Name and Location:** The name of the corporation is Bike Walk Indian River County, Inc. The initial office of the corporation is 1994 6th Avenue, SE, Vero Beach, Florida 32962, located in Indian River County.

**Article Two. Mission:** The corporate mission is to promote safe bicycling and walking as transportation and recreation for a healthier, more vibrant and connected Indian River County.

**Article Three. Exempt Purpose:** The corporation is organized exclusively for the purpose of promoting its mission through educational and charitable efforts, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article Four. Private Inurement:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article Five. Disposition of Assets on Dissolution:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any

such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article Six. Officers and Directors:** Officers and Directors shall be selected in accordance with the process set out in the Bylaws.

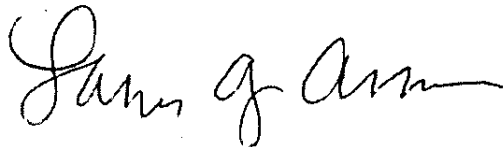
