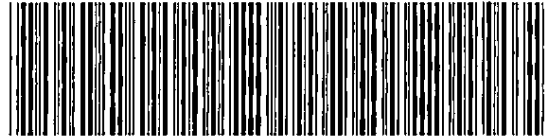

Pursuant to the provisions of section 607.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendments to its Articles of Incorporation:

**Article Three. Exempt Purpose:** The corporation is organized exclusively for the purpose of promoting its mission through educational and charitable efforts, including, for such purposes, providing activities that contribute to the development of good character or good sportsmanship, or to the educational or cultural development, of minors and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

This Amendment was unanimously adopted by the Board of Directors, member action not required, at a regular Board of Directors' meeting held on January 3, 2024.
