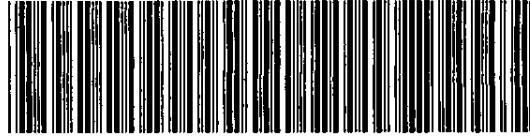

ARTICLE I – NAME

The name of the corporation shall be: Provisional Government of Afghanistan, Corporation.

ARTICLE II – PLACE OF BUSINESS

The principal place of business and mailing address of this corporation shall be:

519 SW Bayshore Boulevard
Port St. Lucie, Florida 34983

ARTICLE III – PURPOSE

The purposes for which the corporation is organized are:

- a. Provisional Government of Afghanistan, Corporation, organized for exclusively religious, charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under said Section 501(c)(3) of the Internal Revenue Code of 1986. Specifically, the organization will mediate and attempt to resolve social and territorial disputes.
- b. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- c. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

ARTICLE IV – INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of one member. The number may be increased or decreased from time to time by the manner and terms provided in the Bylaws. The name and address of the Director constituting the initial Board of Director is:

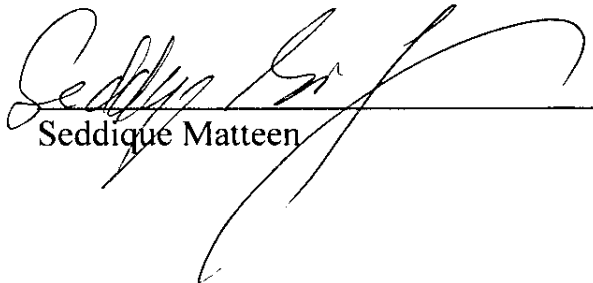
