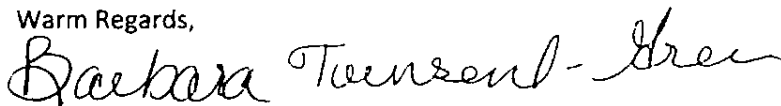
Dear Lawrence:
