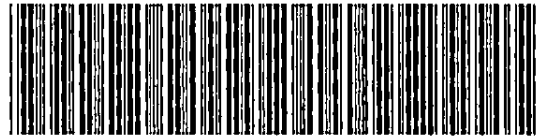

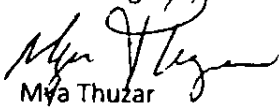
Dear Lawrence:
