**ARTICLE I
CORPORATE NAME**

The name of the corporation is:

DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE IV
GENERAL AND SPECIFIC PURPOSES**

Section I – General Purpose

JESUS LOVE INTERNATIONAL MINISTRIES, INC., is a Christian organization who ministers to all persons helping them worship God, have fellowship, conduct missionary efforts around the world, provide food, shelter, pre-school and adult education and instruction in the love of Jesus Christ. We are an intentional multi-cultural faith ministry focused on preaching the word of God while also providing teaching material for pastors, churches, fellowship groups and conduct seminars to help strengthen the Body of Jesus Christ here and around the world.

Said corporation will govern itself and conduct its own affairs according to the New Testament Scriptures. This right shall include such matters as the hiring of ministers and employees, election of the Board of Directors and officers, the acceptance and discipline, the conduct of its own meeting, services, performance of weddings and funerals, if it chooses to do so, usage of facilities, program(s) and all business matters.

Said corporation will establish and maintain a ministry providing a witness of Almighty God, our heavenly father; His son Jesus Christ, to provide Christian fellowship for those of like precious faith, where the Holy Spirit may be honored according to our distinctive testimony.

Section II – Internal Revenue Service

Said corporation is organized exclusively for charitable, religious, educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on

- (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or
- (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

**ARTICLE V
AFFILIATION**

While maintaining its inherent rights to sovereignty in the conduct of its own affairs as herein set forth, JESUS LOVE INTERNATIONAL MINISTRIES, INC., voluntarily commits to enter into fellowship and partnership with like-minded organizations as it sees fit or is necessary to accomplish its mission. We shall initially incorporate as a nondenominational ministry. Future denominational alignment shall undergo approval by the Board of Directors.

**ARTICLE VI
LEADERSHIP**

The ministry shall be Board of Director led.

**ARTICLE VII
CORPORATE BOARD OF DIRECTORS AND OFFICERS**

The board of directors and officers of the corporation shall be persons of mature Christian experience and knowledge, who shall meet the requirements of Acts 6, I Timothy 3 and Titus 1. The manner in which the directors and officers are elected or appointed shall be set forth in the Bylaws.

ARTICLE VIII DISSOLUTION

Upon the dissolution of the organization, none of its funds or assets shall be distributed to any officer director, trustee, or any other individual. The board shall, after paying or making provision for the payment of all of the liabilities of the ministry, distribute funds and assets for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such funds or assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such religious purpose.

ARTICLE XII: DEBTS


Neither members of the Board of Directors or Officers of the Corporation shall be liable for the debts of the Corporation.

ARTICLE XIII: AMENDMENT

This corporation reserves the right to amend, alter, change or repeal any provision contained in the Articles of Incorporation, or any amendments hereto, and to enact By-Laws, in manner now or hereafter prescribed by law and all rights conferred on Directors and Officers herein are granted subject to this reservation.
