ARTICLES OF INCORPORATION

(A Florida Not For Profit Corporation)

The undersigned incorporator, for the purpose of forming a Corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, does hereby adopt the following restated Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be: Forever Farm Sanctuary, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be: 1016 Dillon Circle, New Smyrna Beach, FL 32168.

ARTICLE III - PURPOSE

- A. The general nature and object of the Corporation shall be to provide proper housing and care for any domestic animal including orphaned, handicapped, ones requiring rehabilitation or of retirement age.
- B. The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- C. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
