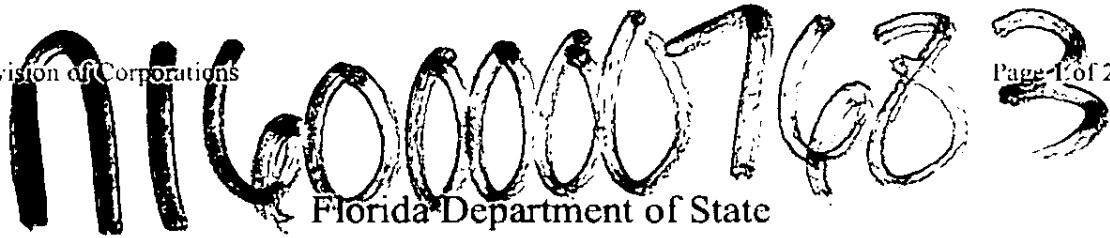

**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
EDGEWATER WALK II ON HARBOUR ISLE, A CONDOMINIUM ASSOCIATION,  
INC.**

Minto Bradenton, LLC, a Florida limited liability company (the "Developer"), pursuant to Section 10.3 of the Articles of Incorporation of Edgewater Walk II on Harbour Isle, a Condominium Association, Inc., a Florida not-for-profit corporation (the "Association"), filed with the Secretary of State of the State of Florida under document number N16000007683 ("Articles"), which provides that until termination of the Class B Membership (as defined in the Declaration), the Developer has the right to amend the Articles without the approval or joinder of any other party, hereby makes the following changes to the Articles:

**FIRST:** Section 6.1 of the Articles is hereby amended to read as follows:

6.1 The affairs of the Association shall be managed by a Board of Directors ~~who~~ whose Directors, until the turnover of the Association to Unit Owners other than the Developer, need not be members of the Association. The membership of the Board shall consist of not less than three (3) not more than (5) Directors until the control of the Association is transferred to the Unit Owners other than the Developer pursuant to Florida Statutes § 718.301. Thereafter, the Board shall consist of not less than five (5) Directors, all of whom shall be members, provided, however, that the Board shall always consist of an odd number of Directors.

**SECOND:** This Amendment was approved by Developer on the 22<sup>nd</sup> day of January, 2018.



**THIRD:** The Board of Directors and the Members are not entitled to vote on the amendment as the termination of Class B Membership has not occurred as of the date of this Amendment.


**FOURTH:** The Declaration of Condominium for Edgewater Walk II on Harbour Isle, a Condominium, was recorded on October 27, 2016, in Official Records Book 2645, Page 1531, *et. seq.*, of the Public Records of Manatee County, Florida.
