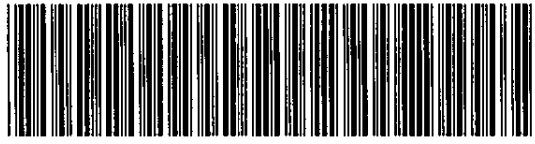

FLORIDA NON PROFIT ARTICLES OF INCORPORATION

In Compliance with Chapter 617.0202, F.S.,(Not for Profit)

ARTICLE I: NAME OF CORPORATION

The Name of the Corporation shall be, **MINISTERIO INTERNACIONAL ESTRELLA DEL ORIENTE INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal address of the Corporation is: **608 WEST 28 ST HIALEAH FL 33010**

ARTICLE III MAIL ADDRESS

ARTICLE IV PURPOSE

MINISTERIO INTERNACIONAL ESTRELLA DEL ORIENTE INC, is a non-profit corporation. The corporation is organized exclusively for religious, charitable, and educational, purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purpose for which is initially organizes is to teach and preach the gospel to all people, establish places of worship, conduct evangelistic and humanitarian activities and promote Christian values of love and brotherhood in the community.

ARTICLE V DURATION

The period of duration of the corporation is perpetual.

ARTICLE VI MANNER OF ELECTION

The manner in which the directors are elected or appointed is provided in the bylaws of the corporation.

ARTICLE VI LIMITATIONS

No part of the net earnings of **MINISTERIO INTERNACIONAL ESTRELLA DEL ORIENTE INC,** shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

MINISTERIO INTERNACIONAL ESTRELLA DEL ORIENTE INC, is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and religious purposes.

ARTICLE VII LIABILITY

No officer or director of this corporation shall be personally liable for the debts or obligations of **MINISTERIO INTERNACIONAL ESTRELLA DEL ORIENTE INC** , of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VIII DISSOLUTION

Upon termination or dissolution of the **MINISTERIO INTERNACIONAL ESTRELLA DEL ORIENTE INC**, any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code (or described in any corresponding provision of any future tax code) or shall be distributed to the Federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, as said Court shall determine which are organized and operated exclusively for such purposes.

ARTICLE IX RESTRICTED ACTIVITIES

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE X BOARD OF DIRECTOR




