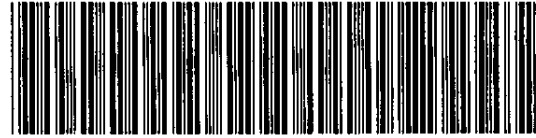

I. Name

The initial Board of Directors will be appointed by the incorporator (s) once the entity is incorporated as a domestic corporation of the State of Florida.

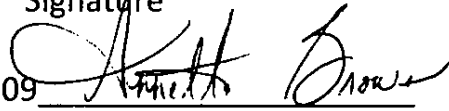

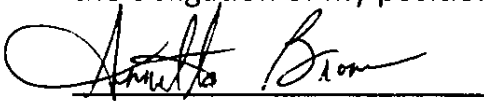
