ARTICLE I CORPORATE NAME

The name of the corporation is:

ARTICLE II CORPORATE ADDRESS

ARTICLE III DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV GENERAL AND SPECIFIC PURPOSES

Section I - General Purpose

ARM OF HOPE, INC., is a Christian organization who ministers to all persons helping them worship God, have fellowship, conduct missionary efforts around the world, provide food and water, shelter, pre-school and adult education and instruction in the love of Jesus Christ. We are an intentional multi-cultural faith ministry focused on preaching the word of God while dedicated to meeting the fundamental needs of disadvantaged minorities who are impoverished and live in remote communities in Africa and around the world. We provide education, healthcare, legal aids, borehole water, emergency relief and skill acquisition.

We believe that every human being, irrespective of race, ethnicity, religion and circumstances such as location, social and economic background, should have access to clean and safe drinking water in the love of Christ.

Said corporation will govern itself and conduct its own affairs according to the New Testament Scriptures.

Section II - Internal Revenue Service

Said corporation is organized exclusively for charitable, religious, educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on

- (a) by an organization exempt from Federal income tax under section 501 (c)
 (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or
- (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

ARTICLE V AFFILIATION

While maintaining its inherent rights to sovereignty in the conduct of its own affairs as herein set forth, ARM OF HOPE, INC., voluntarily commits to enter into fellowship and partnership with like-minded organizations as it sees fit or is necessary to accomplish its mission.

ARTICLE VI

This corporation shall be Board of Director led.

ARTICLE VII CORPORATE BOARD OF DIRECTORS AND OFFICERS

The board of directors and officers of the corporation shall be persons of mature Christian experience and knowledge, who shall meet the requirements of Acts 6, I Timothy 3 and Titus 1. The manner in which the directors and officers are elected or appointed shall be set forth in the Bylaws.

Any such funds or assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such religious purpose.
