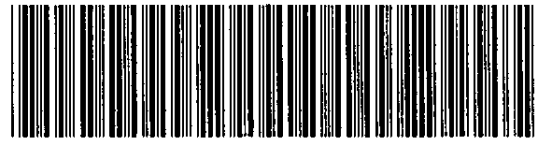

# Articles of Incorporation

In compliance with Chapter 617, F.S., (Not for Profit)

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation pursuant to Chapter 617, Florida Statutes, the Non-Profit Corporation Laws of the State of Florida, do hereby certify:

## Article I - NAME:

The name of the Corporation shall be Royalty Rescue Corporation.

## Article II - PRINCIPAL OFFICE:

The place in this state where the principal office of the Corporation is to be located is the 5175 Ronald Reagan Boulevard, Sanford, Seminole County, FL 32773

## Article III - PURPOSE:

Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific purpose of this corporation shall be to:

- Save, protect and improve the lives of homeless and abandoned dogs;
- Provide veterinary care to rehabilitate dogs to restore health;
- Provide training to re-socialize dogs in preparation for adoption; and
- Place homeless and abandoned dogs into adoptive homes.

## Article IV - MANNER OF ELECTION:

The number of directors, and the method of selecting directors, shall be fixed by the Bylaws of this corporation. The initial directors shall be three (3) in number. The Directors shall be elected by majority vote of a quorum of the Directors present and voting.

**Article V - INITIAL OFFICERS AND DIRECTORS:**

The names and addresses of the persons who are the initial Directors of the corporation are as follows:

Dr. Joseph Angley, 1003 Fleck Avenue, Orlando, FL 32804, Secretary/Treasurer

Charles Hanlon, 5175 Ronald Reagan Boulevard, Sanford, Seminole County, FL 32773, Director

**Article VI - REGISTERED AGENT:**

The initial registered agent for this corporation shall be Ronald Daniel Sanchez Fu. The physical address for the Registered Agent is 1003 Fleck Avenue, Orlando, FL 32804.

**Article VII - INCORPORATOR:**

The Incorporator for this corporation is Dr. Joseph Angley, whose address is 1003 Fleck Avenue, Orlando, FL 32804.

**Article VIII - EFFECTIVE DATE:**

The effective date is the filing date.

**ARTICLE IX - ADDITIONAL PROVISIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

*Royalty Rescue Corporation Articles of Incorporation*

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE X - DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
