#### ARTICLE OF INCORPORATION

### EYES WIDE OPEN CHARITABLE FOUNDATION INC.

I, the undersigned, a natural person competent to contract, do hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a non-profit corporation under the laws of the State of Florida pursuant to Chapter 617, Florida Statutes (F.S)

### ARTICLE 1 NAME OF CORPORATION

The name of the corporation shall be EYES WIDE OPEN CHARITABLE FOUNDATION INC.

### ARTICLE II PURPOSE

The general nature of the Corporation is organized exclusively for charitable, religious and educational services to the community that qualify as exempt under code section 501(c) of the corresponding section of any future federal tax codes.

#### ARTICLE III PROHIBITION

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to make payments and distributions in furtherance to the purposes set forth. The Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Service code; per the correspondence section of any future federal tax code or (b) by a Corporation, contributions to which are deductible under code section 170 (c) of the Internal Revenue Service code.
