Pursuant to Section 617.1401(a) of the Florida Not For Profit Corporation Act (the "Act"), Pinellas Reading Council, Inc., a Florida not for profit corporation (the "Corporation"), hereby adopts the following Articles of Dissolution:

**ARTICLE I
Name**

The name of the Corporation is Pinellas Reading Council, Inc.

**ARTICLE II
Filing Date; No Commencement of Affairs; No Unpaid Debts**

The Corporation filed its Articles of Incorporation with the Secretary of State of the State of Florida on June 19, 2017 ("Filing Date"). Subsequent to the Filing Date, the Corporation has not elected any directors and has not commenced to conduct its affairs. As of the date hereof, the Corporation has no debts that remain unpaid.

**ARTICLE III
Dissolution Authorized**

The Corporation has no directors or members. The incorporator of the Corporation has duly approved and adopted the Articles of Dissolution in accordance with Section 617.1401(1)(a) of the Act pursuant to an action taken by written consent dated June 29, 2018. Accordingly, the Articles of Dissolution have been authorized by all appropriate action under the Act.

These Articles of Dissolution shall be effective when filed.
