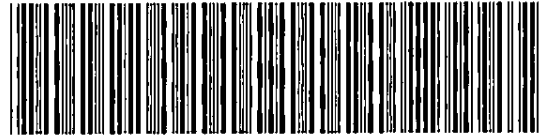

Pursuant to the provisions of section 617.1006, Florida Statutes, Independence Landing, Inc., a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Amendment adopted:

ARTICLE III PURPOSES shall be deleted and replaced with the following:

**III.
PURPOSES**

The purposes for which the Corporation are formed:

This Corporation's purposes are solely and entirely charitable, religious, spiritual, educational and scientific, solely within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("IRC"), and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida and IRC Section 501(c)(3), and within such type of activities, its purposes include:


- A. To develop an affordable housing, planned residential community for adults with disabilities with support, mentoring, coaching and educational opportunities to enhance independence, life, work and recreation.
- B. To provide affordable, supportive and safe housing for low and moderate income individuals with a wide range of cognitive abilities in conjunction with social, vocational and employment opportunities fostering maximum independence.
- C. To foster low income housing.
- D. To sponsor workshops and educational forums, both in person and online, to allow for education and discussion of supporting individuals with disabilities and other special needs.
- E. To encourage community support for individuals with disabilities and other special needs.
- F. To take all actions to advance the purposes described above.

SECOND: In all other respects, the Articles of Incorporation remain unchanged and are hereby ratified.

There are no members of Independence Landing, Inc. This amendment was approved by the Board of Directors of Independence Landing, Inc. on March 19, 2019.
