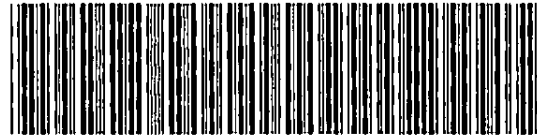

**ARTICLES OF INCORPORATION  
OF  
CAFÉ CON TAMPA INC.**

The undersigned incorporator, for the purposes of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

**ARTICLE I – NAME**

The name of the Corporation is:

CAFÉ CON TAMPA, INC.

**ARTICLE II – ADDRESS**

The principal place of business address for the Corporation is:

2909 W. Bay to Bay Blvd., Suite 108, Tampa, FL 33629.

**ARTICLE III – SPECIFIC PURPOSE**

Café con Tampa is organized and established for the purpose of providing a forum to permit interested individuals to gather to discuss and be informed about issues of importance to the Tampa Bay region. The Corporation may also engage directly or indirectly in other activities of a charitable, artistic, scientific, literary and educational nature that would permit it to qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any statute of similar import.

**ARTICLE IV - DISSOLUTION**

Upon Dissolution of the Corporation, the Board of Directors shall, after paying or making provision for payment of all liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such a manner as to such organization or organizations organized and operated exclusively for civic, charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section (C)(3) or (4) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by distribution to the Federal Government or to a state or local government for public purpose.

**ARTICLE V - BOARD OF DIRECTORS MANNER OF ELECTION**

The manner in which directors are elected or appointed shall be as provided in the Bylaws of the Corporation.

**ARTICLE VI - INITIAL DIRECTORS**

The Corporation shall have no members. The management of the affairs of the Corporation shall be vested in a Board of Directors, as defined in the Corporation's Bylaws. No Director shall have any right, title, or interest
