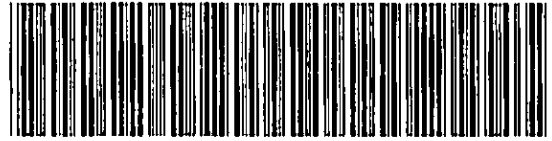

The specific purpose for which this corporation is organized:


