



**ARTICLES OF AMENDMENT**

The Name of the Corporation is **ORANGE RIBBONS FOR JAIME, INC.** ("Corporation"). The Corporation's Florida Department of State's Document Number is **N1800002813**).

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

**A.** Article II of the Articles of Incorporation of Corporation are hereby amended by deleting the mailing address of corporation in its entirety and inserting the following in lieu thereof:

"The new mailing address of Corporation is: 5944 Coral Ridge Drive # 301, Coral Springs, Florida 33076."

**B.** Article III of the Articles of Incorporation of Corporation are hereby amended by deleting Article III in its entirety and inserting the following new Article III in lieu thereof:

"ARTICLE III

The specific purpose for which this Corporation is organized is:

(A) The Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue law or tax code). The Corporation's purpose includes, but is not limited to, support to children through dance education and gun safety education.

(B) This Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property or net earnings of the Corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. The Corporation shall not carry on propaganda, or otherwise attempt to influence legislation to such extent as would result in loss of its exemption from

federal income tax under Section 501(c)(3) of the Code, and the Corporation shall not participate in, or intervene in (including publication or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code (or the corresponding provision of any future United States Internal Revenue law)."

C. The Articles of Incorporation of Corporation are hereby amended by adding a new Article IX to read as follows:

"Article IX"

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes."

D. There are no members or members entitled to vote on the amendments. The amendments were adopted by the board of directors in accordance with section 617.1006 (4) and adopted on March 22, 2018.

Corporation has caused these *Articles of Amendment to the Articles of Incorporation of Orange Ribbons For Jaime, Inc.* to be executed in its name and on its behalf as of the 30<sup>th</sup> day of April 2018.
