

ARTICLE I.

The name of the corporation is **Dunedin Cove Homeowners Association**, Inc., hereinafter called the "Association".

ARTICLE II.

The principal office of the Association is located at 9400 River Crossing Blvd., Suite 102, New Port Richey, Florida 34655.

ARTICLE III.

Richard J. Deeb, II, whose address is 9400 River Crossing Blvd., Suite 102, New Port Richey, Florida 34655, is hereby appointed the initial registered agent of this Association.

ARTICLE IV.
