The corporation may receive and administer funds for educational, social and charitable purpose, within the meaning of section 501(c)(3) of the Internal Revenue Code and to that end the Corporation is empowered to hold any property, or any undivided interest, therein without limitation as to amount or value, to dispose of any such property and to invest, reinvest or deal with the principal or the income in such manners, in the judgment of the directors, will best promote the purposes of the Corporation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the bylaws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors officers except as permitted under the Not-for-Profit Corporation Law.


