Pursuant to the provisions of section 617.0124 Florida Statutes, this document is being submitted to correct the Articles of Incorporation of Carol Kimmelman Academic and Athletic Campus, Inc.

FIRST: The name of this Florida not for profit corporation is CAROL KIMMELMAN ACADEMIC AND ATHLETIC CAMPUS, INC. (the "Corporation").

SECOND: The Articles of Incorporation of the Corporation were filed with the Florida Department of State on November 16, 2018, and assigned document number N18000012177.
