**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
BOCA RATON ARTS DISTRICT EXPLORATORY CORPORATION**

Pursuant to Section 617.1002 and 617.1006 of the Florida Not-For-Profit Corporation Act (the "Act"), BOCA RATON ARTS DISTRICT EXPLORATORY CORPORATION, a Florida not for profit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST:** The name of the company is BOCA RATON ARTS DISTRICT EXPLORATORY CORPORATION (the "Company").
- SECOND:** The Articles of Incorporation of the Company were filed with the Florida Department of State on December 4, 2018 and Amended and Restated on February 14, 2022, under Document Number N18000012690.
- THIRD:** The following amendment to the Articles of Incorporation was adopted by the Company:
- Article I of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE I – NAME**

The name of this not-for-profit corporation is The Center for Arts & Innovation Inc., (the "Company").

- FOURTH:** The date of the adoption of the amendment was July 12, 2022.
- FIFTH:** The amendment was adopted by the board of directors, as required by this chapter and by the articles of incorporation and bylaws, and that member approval was not required.
