ARTICLES OF INCORPORATION

THE CLEARWATER BAR FOUNDATION, INC.
(A Corporation Not for Profit)

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned, being all residents of the State of Florida and of full age, hereby associate themselves together for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida, and certify as follows:

ARTICLE I

Name

The name of this corporation is THE CLEARWATER BAR FOUNDATION, INC., hereafter called the "Foundation".

ARTICLE II

Office

The initial principal office of the Foundation shall be located at 6 Fort Harrison Avenue South, Clearwater, Florida 33516, which office may be changed from time to time by action of the Board of Trustees.

ARTICLE III

Registered Office and Agent

The street address of the initial registered office of the Foundation shall be 2515 Countryside Boulevard, Suite A, Clearwater, Florida 33575, and the name of the Foundation's initial registered agent at such address shall be Julius J. Zschau.

ARTICLE IV

Purposes

The general purposes of the Foundation are:

1. To foster programs of law-related education for students and adults, including where appropriate: publications; workshops; and related programs.
2. To encourage and promote legal assistance to the poor and to disadvantaged groups.

3. To support and promote programs and projects having as their purpose the improvement of the administration of justice, and the provision of information to the public that it may better understand the courts and legal processes.

4. To award grants for scholarships and fellowships, but will strive to do so under circumstances that will promote the general public welfare rather than for the personal benefit of the individual donees.

5. To support continuing legal education programs, particularly programs of an experimental nature or of general interest to the entire legal profession in the community and are not self supporting.

In pursuing its purpose, the Foundation does not provide funds to be used for propaganda or lobbying.

To enable it to attain its purposes, the Foundation shall have all of the powers given to not-for-profit corporations by the laws of the State of Florida, and particularly Section 617.021, Florida Statutes (1985).

ARTICLE V

Restrictions

The following additional provisions are inserted for the regulation of the affairs of the Corporation:

A. The Foundation is organized to receive and maintain real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code and regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

B. The Foundation shall distribute its income for each taxable year at such time and in such manner as not to become subject to tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws. The Foundation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws. The Foundation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws. The Foundation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax

laws. The Foundation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws.

C. No part of the net earning of the Foundation shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private individuals, except that the Foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the Foundation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, this Foundation will not conduct or carry on any other activities not permitted to be conducted or carried on (1) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code, and regulations issued pursuant thereto, as they now exist or may hereafter be amended, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or regulations issued pursuant thereto, as they may now exist or may hereafter be amended.

ARTICLE VI

Members

A. Membership in the Foundation shall be composed of two classes: Voting Members and General Members.

B. The Voting Members shall be the immediate Past President, the President, the President-Elect, the Secretary, the Treasurer and the last four past presidents of the Clearwater Bar Association, Inc., a Florida not-for-profit corporation, and two additional individuals elected by the foregoing.

C. General Members shall be all persons who apply to the Foundation for General Membership on forms adopted by the Foundation, and who further meet the requirements for General Members as adopted by the Board of Trustees from time to time. General Members shall not be entitled to vote, nor shall they be considered in determining a quorum. The General Membership status of a person shall terminate annually on December 31, unless renewed by action of the Board of Trustees. The status of a person as a General Member may be terminated at any time upon majority vote of the Board of Trustees.

ARTICLE VII

Board of Trustees

The affairs of the Foundation shall be managed by a Board of Trustees initially composed of nine (9) trustees, who need not be members of the Foundation. The number of trustees may be changed by amendment to the By-laws of the Foundation. The trustees shall be elected at the annual meeting of the Voting Members. The term of office of the trustees shall be for a one (1) year period. The names and addresses of the persons who shall constitute the initial Board of Trustees are as follows:

The Board of Trustees is authorized to designate an Executive Committee.

ARTICLE XI

Indemnification

Every Trustee and every officer of the Foundation shall be indemnified by the Foundation to the fullest extent of the law against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed on him in connection with any proceeding or settlement of any proceeding to which he may become involved by reason of his being or having been a Trustee or officer of the Foundation, whether or not he is a trustee or officer at the time such expenses are incurred.

ARTICLE XII

Duration

This Foundation shall exist perpetually.

ARTICLE XIII

By-Laws

The By-Laws of this Foundation shall be initially adopted by the Board of Trustees. Thereafter, the By-laws shall be altered, amended or rescinded only upon the four-fifths (4/5ths) vote of the entire Board of Trustees.

ARTICLE XIV

Amendments


These Articles of Incorporation shall only be amended or modified upon the four-fifths (4/5ths) vote of the entire Board of Trustees.

ARTICLE XV

Dissolution

In the event of the dissolution of the Foundation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the Foundation, dispose of all of the assets of the Foundation exclusively for the purposes of the Foundation in such manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) and 170 (c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the Foundation is then located, exclusively for such purposes or to such organization or organizations, as such Court shall determine, which are organized and operated exclusively for such purposes.


