THE UNDERSIGNED, each with the capacity to contract, hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of Florida as contained in the provisions of Florida statutes, Chapter 617, Part I, as amended (the "Act").

ARTICLE I. NAME

The name of this corporation shall be TRINITY ASSEMBLY OF GOD OF MANATEE COUNTY, INC.

ARTICLE II. PURPOSE AND POWERS

The purposes for which this corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) or the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE III. QUALIFICATION OF MEMBERS

1. Membership
