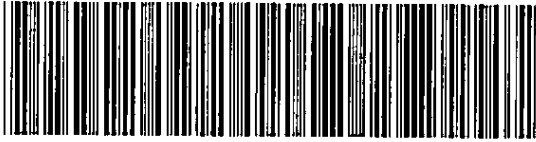

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, being of legal age, does hereby, for the purposes of becoming a not-for-profit corporation, under the laws of the State of Florida authorizing the formation of a not-for-profit corporation, make the following:

ARTICLE I
NAME OF CORPORATION

ARTICLE IX
DISPOSITION OF ASSETS UPON DISSOLUTION

disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

These Articles of Incorporation may be altered, amended, or added to by a two-thirds (2/3) vote of the Board of Directors of the corporation present at the annual meeting, or at any other meeting called specifically to alter, amend, or repeal the By-Laws.

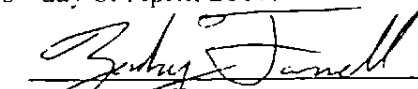

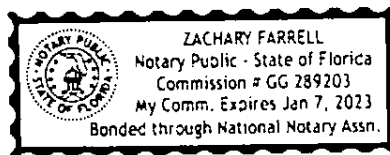
