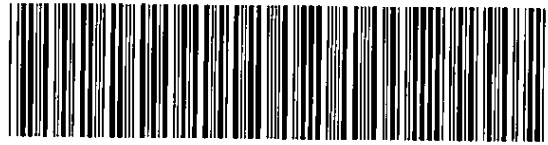

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MINISTERIO INTERNACIONAL BETHEL "CASA DE DIOS", INC.

FIRST:

ARTICLE I – NAME

ARTICLE I – **(AMENDED)** NAME

The name of this corporation should be MINISTERIO INTERNACIONAL BETHEL "CASA DE DIOS" A/D, INC.

SECOND:

ARTICLE II – **(AMENDED)** TO:

ARTICLE II – PRINCIPAL PLACE OF BUSINNES AND MAILING ADDRESS

The principal place of business and mailing address is 8260 Clearly Blvd. Suite 2602, Plantation, FL 33324.

THIRD:

ARTICLE III – PURPOSE(S)

ARTICLE III – **(AMENDED)** TO: PURPOSE AND PRERROGATIVES

The general nature and object of this corporation is for the purpose of establishing and maintaining a place for the worship of Almighty God, our Heavenly Father, to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and in foreign lands; we, whose names appear upon the roster of the MINISTERIO INTERNACIONAL BETHEL "CASA DE DIOS" A/D, INC. as of the day of this signing, do hereby recognize ourselves as a local assembly in fellowship with and a part of the General Council of the Assemblies of God, with headquarters at 1445 Boonville Avenue, Springfield, MO and in fellowship with and a part of the Florida Multicultural District of the Assemblies of God, with headquarters at 830 California Woods Circle, Orlando, FL, and adopt the following articles of church order and submit ourselves to governed by them.

To build, construct, erect, maintain mission stations and mission churches, pastor's home and such other houses or equipment as the corporation may desire for carrying on its work.

To receive, administer, disburse and/or invest gifts, and requests by or from any persons or corporations.

This corporation is further organized for the purpose of holding the title to such property or properties as the MINISTERIO INTERNACIONAL BETHEL "CASA DE DIOS" A/D, INC. shall from time-to-time purchase or acquire and it shall have power from time to time to make such contracts and do such things as shall be authorized and directed by its members. This corporation shall have the power to mortgage, sell, encumber deed, or otherwise dispose of any property, which may belong to the MINISTERIO INTERNACIONAL BETHEL "CASA DE DIOS" A/D, INC. This assembly shall have the right to govern itself according to the standards of the New Testament Scriptures. "Endeavoring to

keep the unity of the faith and of the knowledge of the son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ", Ephesians 4:3, 13.

FOURTH:

ARTICLE VIII – NEW ARTICLE

ARTICLE VIII – AFFILIATION

While maintaining its inherent rights to sovereignty in the conduct of its own affairs, this assembly shall voluntarily enter into full cooperative fellowship with assemblies of like precious faith associated in the Florida Multicultural District, with headquarters in Orlando, FL, and the General Council of the Assemblies of God with headquarters in Springfield, MO; and shall share in the privileges and assume the responsibilities enjoined by that affiliation in Article VI Section 1 of the General Council of the Assemblies of God and in Article XI, Section 2, letter a, of the Florida Multicultural District of the Assemblies of God Bylaws. In the event that the local assembly will like to disaffiliate from the Florida Multicultural District, with headquarters in Orlando, FL, and the General Council of the Assemblies of God with headquarters in Springfield, MO. An Executive from the Florida Multicultural District needs to be present at a special called meeting for such purpose.

FIFTH:

ARTICLE IX – NEW ARTICLE

ARTICLE IX – MEMBERSHIP

The members of the corporation shall be all members in good standing at any given time of said Church Corporation of Florida, provided, however, neither the incorporators nor the members of the corporation shall have any vested right, interest, or privilege of, in or to the assets, functions, affairs or franchises of this corporation, or any right, interest, or privilege which may be inheritable, or shall continue after his membership ceases in the a forenamed corporation. This corporation shall not have the power to buy, mortgage, sell, encumber of deed, or dispose of any property which it may acquire, without the consent or the direction of a two-thirds (2/3) majority vote of the members, or its successor.

SIXTH:

ARTICLE X – NEW ARTICLE

ARTICLE X – TERM

This corporation shall exist perpetually or until dissolved by due process of the law. Should this corporation cease to exist as a legal entity and its charter be terminated, title to all its property automatically shall become vested in the Florida Multicultural District Council of the Assemblies of God, Inc. in the same manner as it holds title to any other property.

SEVENTH:

ARTICLE XI – NEW ARTICLE

ARTICLE XI – DISSOLUTION

In the event this corporation shall cease to function for the purposes herein set forth, then all property, real or chattel, shall revert to the Florida Multicultural District of the Assemblies of God, Inc., under whose supervision this church functions, or to the parent body, the General Council of the Assemblies of God, a Missouri Corporation with headquarters at Springfield, Missouri. The

Florida Multicultural District of the Assemblies of God, Inc. and/or the General council shall have full authority to sell such property and to use the proceeds derived there from for the extension of the work of the Spanish Assembly of God specially those churches that this corporation may have established as daughter churches

EIGHT:

ARTICLE XII – NEW ARTICLE

ARTICLE XII – CONSTITUTION AND BYLAWS

This Corporation shall have the power to govern itself in accordance with its Constitution and Bylaws. The Constitution and Bylaws may be amended in the following manner: the Pastor and the Official Board of Directors must first approve every amendment. Then at a member's business meeting called for that purpose, be approved by two-thirds (2/3) vote of those present.
