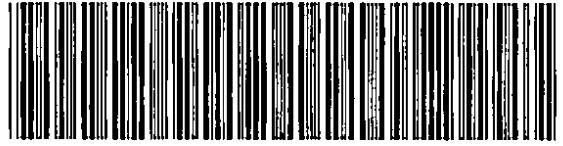

# RESTATED ARTICLES OF INCORPORATION OF Saint New Jerusalem, Inc.

The undersigned incorporator(s), a natural person 18 years of age or older, in order to form a corporate entity adopts the following Restated Articles of Incorporation.

## ARTICLE I

### NAME/REGISTERED OFFICE

The name of this corporation shall be SAINT NEW JERUSALEM, INC. located at 449 Steamboat Spring Drive East, 32210

## ARTICLE II.

### PURPOSE.

This corporation is organized exclusively for charitable purposes. Specifically, SAINT NEW JERUSALEM, INC. was organized to distribute free School supplies, clothes, non-perishable food in urban communities.

Events and activities include our annual back to school supply giveaways located at predetermined locations, Quarterly food drive that are currently held at EWC college. Saint New Jerusalem also participates in events where we partner with other other organizations to help in there initiatives

Every first and third Saturday morning our meetings are held to conduct and coordinate events at the address mentioned above.

Events and activities also include Every fourth Saturday is reserved for fund raising to cover our overhead with

Board members and volunteers participating, fundraisers include but are not subject to selling plates of food, semiannual dance balls, 70s theme parties... all events are for the purpose of covering overhead. To attend these events ticket prices are set by current market value and the amount of our current overhead

**We do not engage in any financial transactions (loans, payments etc.) with our donors or any entities they own entities they control or own**

To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section

501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

### ARTICLE III

#### EXEMPTION REQUIREMENTS.

At all times shall the following operate as conditions restricting the operations and activities of the organization:

1. The corporation shall not afford pecuniary gain, incidentally or otherwise to its members. No part of the net earnings of this corporation shall inure to the benefit of any member of the corporation, except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes. Such net earnings, if any, of this corporation shall be used to carry out the nonprofit corporate purposes set forth in Article II above.
2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code : 1986, as now enacted or hereafter amended.

### ARTICLE IV.

#### DURATION.

The duration of the corporate existence shall be perpetual.

### ARTICLE V.

#### MEMBERSHIP/BOARD OF DIRECTORS.

The corporation shall have one or more classes of members, as provided in the corporation's bylaws. The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. No Director shall have any right, title, or interest in or to any property of the corporation.

OR.

The corporation shall have no members. The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. No Director shall have any right, title, or interest in or to any property of the corporation.

The number of Directors constituting the first Board of Directors is 5, their names and mailing addresses being as follows:

Members of the first Board of Directors shall serve until the first annual meeting, at which their successors are duly elected and qualified, or removed as provided in the bylaws.

#### ARTICLE VI.

#### PERSONAL LIABILITY.

No (member) officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the (members) officer, or Directors be subject to the payment of the debts or obligations of this corporation.

#### ARTICLE VII.

#### DISSOLUTION.

At the time of dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, dispose of all of the assets of the corporation. In no case shall a disposition be made which would not qualify as a charitable contribution under Section 170(c)(1) or (2) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, in such manner as the Board of Directors shall determine.

#### ARTICLE VIII.

This Restated Articles of Incorporation is hereby adopted by the SAINT NEW JERUSALEM, INC. 's board of directors on 09/01/21; member's approval is not
