I want you to know that on June 11th, I called your office at least seven times to make sure the application would not be rejected,going over every detail with a fine tooth comb. I say that only so you know I tried to be in compliance from the onset.

The LLC is an acronym for "Long Live Curtis" and does not serve in any way to denote the category of the corporation. It is not to be confused with the corporation type. LLC was branded by the community of Palm Coast after the fatal shooting of my son Curtis Israel Gray. The kids branded it on social media and it trended for two weeks on Twitter. We are lovingly stuck with it.

Thanks so much for your understanding. The legacy of my son has been embraced by the State of Florida and as far out as California. The Foundation in his name will serve as a platform for violence prevention and positive mental health for kids in our State and nationwide. It will help families find help in time of crisis and help communities provide the resources for immediate recovery for those affected by the cruelty of violence. Your quick response to this matter will be greatly appreciated because I have a long awaited presentation to make before our City & County Council.
