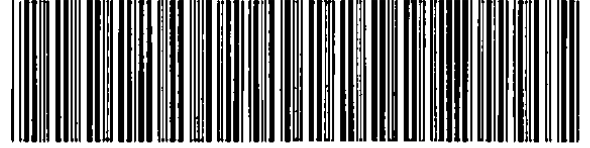

**ARTICLES OF INCORPORATION  
OF

**(Not-For-Profit)**

The undersigned, desiring to form a charitable corporation under Chapter 617, Florida Statutes, as amended, the Florida Not For Profit Corporation Act, does hereby certify:

**ARTICLE I  
NAME**

The name of the corporation shall be RENAISSANCE VENEZUELA, INC.

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office of this corporation shall be 11918 SW 152nd Place, Miami, Florida 33196.

The corporate mailing address shall be the same as the principal address.

**ARTICLE III  
CORPORATE PURPOSE**

The corporation is organized and operated exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More specifically, the corporation will develop and implement projects that support the social, economic, and industrial recovery of Venezuela for the benefit of the general public in Venezuela.

**DURATION**

The period of duration of this corporation is perpetual.

**ARTICLE V**  
**MANNER OF ELECTION**

The manner in which directors are elected is as provided for in the bylaws.

**ARTICLE VI**  
**INITIAL DIRECTORS**

**ARTICLE VIII**

**ARTICLE IX**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

**ARTICLE X**  
**GENERAL LIMITATION ON NONPROFIT ACTIVITIES**

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(e)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE XI**  
**DEDICATION OF ASSETS**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
